Purposes of the REF

To inform the selective allocation of funding for research

To provide accountability for public investment in research and produce evidence of the benefits of this investment

To provide benchmarking information and establish reputational yardsticks, for use in the higher education sector and for public information

Who, what, and how many?

All staff employed on the census date of 31 July 2020 with "significant responsibility" for research must be submitted

A minimum of one and a maximum of five outputs, with an average of 2.5 outputs for each full-time equivalent researcher

Open access

"...to be eligible for submission to the REF 2021, authors' final peer-reviewed manuscripts must have been deposited in an institutional or subject repository. Deposited material should be discoverable, and free to read and download, for anyone with an internet connection.

The requirement applies only to journal articles and conference proceedings with an International Standard Serial Number."

Impact

"...the effect on, change or benefit your research makes to the economy, society, culture, public policy or services, health, the environment or quality of life beyond academia."

(UCA REF terms explained)

25% of the assessment

Environment

Describes the environment we have to support research (e.g. research strategy, staff development, support for postgrads, collaborations, equality & diversity)

'Open research' section (criteria TBC)

15% of the assessment

Scoring

Grades for each element contribute to an overall grade point average (GPA)

GPA for each UOA and for the University as a whole

GPAs are then used for calculating the amount of QR (Quality Related) funding the University receives + league tables

Star ratings

4*	Quality that is world-leading in terms of originality, significance and rigour.
3*	Quality that is internationally excellent in terms of originality, significance and rigour but which falls short of the highest standards of excellence.
2*	Quality that is recognised internationally in terms of originality, significance and rigour.
1*	Quality that is recognised nationally in terms of originality, significance and rigour.
Unclassified	Quality that falls below the standard of nationally recognised work. Or work which does not meet the published definition of research for the purposes of this assessment.
